The Noble House holding the inherited title of Planetary Governor. Have shown interest in Competitions of Artistry.

Remarkably, there are no records indicating that desire for the position of Planetary Governor has ever caused strife among siblings that might inherit the role should the eldest inheritor perish. Quite to the contrary, it would appear that loyalty is a highly valued trait within House Traquiel. Recent intelligence indicates that the House acquired psychoconditioning technology from the Mechanicus sometime ago, which may account for this behavior.

Planetary Governor Dehvon Traquiel



-Planetary Governor of Asterion; Husband of [Kelle Jocasta Lethe](#)

-Accomplished Duelist; shows admirable conduct in the face of defeat, as witnessed in his duel with [Artemis](#) at the party took place at the [Planetary Governor's Palace](#).

-Previously Head of the Royal Guard, prior to his sister's passing; remains largely uninterested in political matters, and generally seems to lack ambition.

-Younger Brother to [Anvephone](#), eldest of her brothers; highly loyal to his sister and her memory.

-Bonded with an [Augmentor](#)

[Heavy Encryption]

-Dehvon is largely unaware of the mission details of KG-Co, including the truth about the death of his Sister and [Niece](#). Maintaining this state of affairs would be prudent.

House Traquiel

Anvephone Traquiel (Deceased)



-Former Planetary Governor of Asterion; killed in a [Xenotechnological Incident](#) in the lava tubes below the hive.

-Historically obsessed with Xenotechnologies; likely worked with and against the [Archmagos](#) at various points in her search.

-[Dehvon](#) was deeply loyal to his sister, and was deeply shaken by her death.

[Heavy Encryption]

-The circumstances of her death were likely caused by the fusion of the [Nemesis Device](#) to [Quinten Cutter](#), as the Device's overseer attacked immediately after Anvephone shot the psyker.

-The truth of the situation was properly obscured to witnesses through misdirection and deception. Though Archmagos Wakes became briefly aware of the situation, his memories appear to have been edited by [VIIR](#) to prevent retaliation. The only remaining rogue element with knowledge of the truth is MIA Company Agent [Gamma Star](#). The threat of exposure has been deemed minimal, given Star's direct action against Anvephone in the conflict, and blackmail held against our former employee.


-Anvephone's fixation on Xenotechnology was likely born of a desire to heal her mutant daughter, [Palinea](#).

-At some point, Anvephone discovered the location of the [Traquiel Fortress](#) and commissioned the aid of [Magos van Flange](#) in constructing a means of accessing it.

-Anvephone's journal entries found at Fort Orpheon indicated that she had a mentor in studying the [Asterii](#). It has since been revealed that identity of this mentor is the Harlequin Solitaire [King Quinque](#), who has extended his insights to [the Ambassador](#).

Metcal Jurgen




-Artist employed by House Traquiel

-Administrator of Traquiel Holdings

-Not particularly charismatic, but quite efficient.

-3rd Eldest of [Anvephone's](#) younger brothers; highly loyal to his sister and her memory

-Dismissed from his position as head of the Traquiel Intelligence service, and replaced with [Father Lightfall](#). Reassigned to nominal authority on the [Asterion Tonic](#) project, to keep him busy.

-Apparently seeing a noblewoman—[Zolyria Haddistad](#)—of his own volition; uncommon for the males of the Traquiel line, who typically only begin courting due to assignments.

-Aspiring duelist

-Attempted to steal the Asterion Tonic formula from the [Magos Biologis](#) (see [House Traquiel Conflicts](#))

House Traquiel

Audric Traquiel



[Recent Events]

-Had deployed near Hive Macharia during the incursion, and is currently MIA, likely KIA

-Youngest of the Traquiel children, currently in school, gifted athlete and academic, sharpshooter, trained in strategic arts.

-Will likely be given a division of Asterion Guard upon graduation.

-Known as handsome and somewhat given to debauchery.

-We have begun to test his competence with simple missions, such as assigning him the task of [boosting the morale of Traquiel forces](#) by leading them in a take down of a minor ganger faction, and celebrating the victory.

-Highly loyal to [Anvephone](#) and her memory.

House Nimea

(-1 Influence)

House that formerly held the position of Planetary Governor, stripped from them and transferred to [House Traquiel](#); according to legend, this occurred per the wishes of an Angel of the God Emperor. This prevents Nimea from outright denouncing the leadership of Traquiel, but a bitter rivalry remains between the two houses.

-Connected with the [Mechanicus](#) via [Magos Biologis Kolabite 62-Ø](#); have been attempting to curry additional favor with [Archmagos Voltaire 19-A](#).

-Red and Grey house colors.

House Nimea

Lady Ketcellia Nimea



-Noble Scion, Niece of the Official Head of House Nimea, but appears to be pulling strings from behind the scenes.

-Assessed to be clever and subtle in her manipulations.

-Developed a friendship with [Kelle](#), though true sincerity unlikely, and their relationship suffered from Kelle's engagement and marriage to [Dehvon Traquiel](#); the ambassador has extended an olive branch in a promise to attempt to unite the noble houses through the marriage of their children.

-Lady Ketcellia performed the role of Maid of Honor at Ambassador Lethe's wedding; she and her family attempted some minor slights towards House Traquiel, including:

--Unveiling a Holo Monument to [Lord General Nimea](#) in the days prior to the ceremony, which depicted a lapel pin with an archaic symbol of House Nimea, used 400+ years ago when their family still held the title of Planetary Governor. (Ambassador Lethe responded with the request for Ketcellia to be her maid of Honor, and was sure that her dress included the family crest used just after the Planetary Governor Title was taken from their house and given to the Traquiel Family)

--Gifted the couple a curated volume of the House Traquiel's history; the stories had been tailored to emphasize the failures and less proud moments of the family.

--Offered a performed choreographed by [Artemis Modeyo](#) that portrayed the last stand and noble defeat of Kore Traquiel. This offer was graciously declined.

-General of the the Asterion Immortals Mechanized Armor Division

-Relative of Father Barnabas Rothay, who's servo skull caused some [mischief](#) in [Bluehull-92](#).

-Recent promotion to Lord General.

Adeptus Mechanicus

Archmagos Sojourner Wakes (Deceased)



-Previous Archmagos of the Asterion Mechanicus

-Fixation on Xenotechnology; his cognomen, Wakes, indicates his dedication to the search for and understanding of Asterii technology.

-Had been scheduled to soon to depart on a pilgrimage to [Eskutchax](#), the sector's primary forge world and manufactory of las weaponry; sentiments strongly suggest that he will there be assigned the role of Fabricator General.

-Severe mental degradation caused the Archmagos to exhibit erratic and violent behaviors, culminating in the necessity of his execution. It is my duty, as a Wakes, to continue his research. To continue his crusade.

-Heavy Encryption-

-Initial contact involved efforts to sway him to endorse [Magos Biologis Kolabite 62-Ø](#).

-Is searching for the records of [Anvephone Traquiel](#) to continue his research into the Xenotechnology of the [Cinquefoils](#); believed them to be stored somewhere on Asterion, but outside the Hive. We have since confirmed the location to be [Fort Orpheon](#), collected the records, and traded them for additional knowledge of the Asterii. He has also promoted me to Magos Logis, and given me permission to use the cognomen "Wakes," which I have chosen to accept.

-His investigations into the death and research of Anvephone Traquiel prompted him to forcibly enter the mind of [Logis Eizen](#) to learn details of the event, and likely of the [Nemesis Device](#). This action caused the Techsorcist code wall containing the entity [VIIR](#) to rupture, allowing him to infect and influence the Archmagos into both forgetting the entire affair, and later to approve the assignment of relic light power armor to Logis Eizen.

-Prior contact with the scrap code associated with VIIR has caused insanity to overtake other tech priests. This is the same fate that befell the Archmagos, who ultimately succumbed to [intense degradation of his mind and functionality](#).

-Before his death, the Archmagos spoke to his "Master," as though he were present; it might be worth learning who that individual is. Additionally, I suspect that Wakes or his Master may also have had contact with [King Quinque](#).

Magos Biologis Kolabite 62-Ø



-Magos Biologis, endorsed to become the next Archmagos after the departure of [Sojourner Wakes](#). However, this endorsement lost value due to Wakes's fall in popularity.

-Strong familial ties to [House Nimea](#); cousin of [Ketcellia](#).

-Oversees production of [Asterion Tonic](#), the chemical nature of which is confidential (though [recent intelligence](#) might reveal the formula)

-To maintain our trade arrangements for Asterion Tonic, the Company has prioritized a positive relationship with the Magos Biologis. To this end, an incredible discovery of Type 87 Thrice Blessed Class-Alpha Sacred Refrigerant in [Bluehull-92](#) was sold to Magos Kolabite for a reasonable price and general favor.

-Attended the Gubernatorial Wedding alongside [Magos Dominus Voltaire 19-A](#) and [Magos Aedifex Vector van Flange](#); gifted the couple a Manufactorium.

Adeptus Mechanicus

Licensed Elevator Repairman Cassius Omega-22



-Elevator Repairman/Infrastructure Representative in the absence of [Magos Vector van Flange](#).

-Associate of [Logis Kelvin 111](#).

-Tracks rumors and discussion within the Mechanicus with reasonable consistency; information has often proved valuable.

Factotum Fexibaan 77-b



-Mechanicus Factotum in service to the [Nimea](#) family. Expert in social sciences and interactions.

-Attended the Gubernatorial Wedding with the Nimea Family.

Adeptus Mechanicus

Archmagos Dominus Voltaire

19-A



-Elected Archmagos following the death of [Sojourner Wakes](#)

-Served as an Ambassador of Archmagos Wakes interested during negotiations for the repairs of [Port Lysander](#)

-Attended the Gubernatorial Wedding alongside [Magos Biologis Kolabite 62-Ø](#) and [Magos Aedifex Vector van Flange](#); gifted the couple a Manufactorium. During the wedding, engaged [Magos Logis Eizen](#) in a discussion regarding the election of the next Arch Magos, as he is currently leading the polls. I gave honest replies to his answers, both in my assessment that the value of Magos van Flange's rivalry with Archmagos Wakes was being underestimated in current polity, and that I personally will vote for the Magos Aedifex. He appeared to take no offense to these calculations.

Magos Aedifex Vector van Flange



-Head Magos of the Infrastructure Department; well regarded by his subordinates.

-Had been absent for some time, having vanished during an exploration of the lava tubes, where his telemetry continued to report his location and status as alive, but out of reach—he went there searching for an optimal cargo route through the planet between two of Asterion's hives. [Sojourner Wakes](#) considered this a non-issue at this time, and neglected to appoint a replacement leader for the Infrastructure Department, evidence of the friction between the two.

-Van Flange has since indicated similar dislike (and mistrust) toward Wakes; their cognomens indicate the source of this discord, as the van Flange line believes in the need to improve upon practical engineering and technologies, whereas the Wakes line is focused on seeking and understanding new/lost technologies. Due to this conflict, I made sure to be clear of my ongoing respect for van Flange after adopting the Wakes Cognomen, the truth of which he appears to have accepted.

-Was safely recovered during by team due to interest in aiding/gaining influence with the Infrastructure Department, and possibly obtaining insight into the location of the lost [Traquiel Fortress](#); these goals have been achieved. In addition, this mission led us to the discovery of [the 508](#) and it's denizens.

-Long absence occurred due to the actions of [Ssar Wolstina](#), in her misguided attempts to preserve and protect the [Chosen 508th](#).

-Van Flange has confirmed that [Anvephone Traquiel](#) enlisted his confidential aid in constructing a throughway to the original Traquiel Palace; how she discovered its location to begin with remains unknown. He later provided a means of entrance to Fort Orpheon, and joined us in our initial exploration. His presence necessitated him being made aware of the [Asterii Devices](#), when one was encountered.

-Attended the Gubernatorial Wedding alongside [Magos Dominus Voltaire 19-A](#) and Magos Biologis Kolabite 62-Ø; gifted the couple a [Manufactorium](#).

-Since we were unable to sway the election toward Magos van Flange, we have attempted to maintain our positive connection through other means. This includes formatting our Manufactorium to produce cable necessary for infrastructure projects.

-Infrastructure department Logis, associate of [Cassius](#); works at the Comutotitron Chapel, where many communications are routed through the hive and between orbitals. He and the entire department currently favor KG-Co with great enthusiasm, due to our aid in recovering [Magos Vector van Flange](#).

[Heavy Encryption]

-Has agreed to covertly aid us by intercepting the communications of the [DeWonti Trade Consortium](#) and delivering them to KG-Co. Delivery of these reports has been conducted thus far by Cassius.

Adeptus Mechanicus

Magos Techsorcist Voss

Alpha-1



-Itinerant Techpriest that travels the Cytheris Subsector, remaining in one system or another for 1-3 years before relocating for work.

-A (largely) tolerated radical, as many techsorcists are in the Mechanicus; work necessitates the use of improvisational measures during some rituals, as well as the large-scale destruction of sacred machine spirits that have succumbed to heretical infections. More driven by profit than the average techpriest.

-Aggressively avoids records of himself and whereabouts reaching the Noosphere, due to friction with other orders of techpriests.

-Confidentially retained by [Rear Admiral von Trakkyr](#) in efforts to purge a schismatic scrap code from the Naval Warship, [the Judgment of Eminence](#). Progress is being made steadily, if slowly, and he seems to have included several backdoor programs into the system, and copied a number of files to personal records.

-We sought out the aid of Magos Voss in curing [Archmagos Wakes](#) of his deteriorating condition; to accomplish this, we had to disclose information regarding [Magos Eizen](#), [VIIR](#), and the wall in their shared mind. For the Cost of 1 Liquidity and ongoing retainer with the Keojrah-Glynt Company, we have secured his aid in this matter.

Adeptus Mechanicus

Knight Archivist Ruber Sutonis



-An archival techpriest trained in the mysteries of Techsorcism; as with others of this initiation, his beliefs are not as strictly orthodox as others in the Mechanicus.

-Currently in [Hive Cytheris](#), working for a scrapper company in the [Quarantine Zone](#) to assist in the removal of scrap code infections from recovered devices.

-Familiar with [Sojourner Wakes](#), and his mission; contact was made with [Magos Eizen](#), due to his status as the Wakes Cognomen Successor, upon recovery of a Voiddelver artifact during exploration of the Quarantine Zone. The Device was recovered from an individual belonging to the [Order of Silence](#), who attacked Ruber alongside the insectoid denizens of the Zone.

-Sutonis has been updated on the situation with the VIIR Engram, and has suggested a possible location of use within the Zone.

Adeptus Mechanicus

Magos Helexicon Theta-9



-Magos from [Eskutchax](#), accompanied by apprentice [Engineer Anealia Theta-9](#). Had contact with [Sojourner Wakes](#); was apparently similarly minded in being less orthodox in beliefs, hence leaving the Forge World to come to Asterion to seek a more open-minded setting for research and theory craft.

-Specialist in Machine Spirits; claims to be studying methods of machine spirit resurrection. He and the Engineer have since provided us with a more detailed demonstration of this process.

-Had intended to reach out to [Voss Alpha-1](#) and [House Nimea](#) for possible resources and support; to avoid them becoming assets to a different faction, they were offered (and accepted) space for a laboratory in [Bluehull-92](#).

-Currently overseeing the resurrection of the [Norimar Corpse Starch Manufactory](#) with Engineer Theta-9

Engineer Anealia Theta-9



-Apprentice to [Magos Helexicon Theta-9](#)

-Studying machine spirit ecosystems, and the possibility of several compatible spirit existing in cohabitation within a single device. Has offered access to this research, as part of ongoing agreement to support her and her mentor's efforts.

-Has great potential.

-Initially contacted by [Gamma Star](#) at the Manor Party; provided the company with a semi-mocking "calling card" for a Vox Channel, which seems nonetheless capable of attracting his attention.

-Attended the Gubernatorial Wedding nominally disguised as part of the [Astra Telepathica's](#) retinue; throughout the event, he seemed to be keeping an eye on [the Lord Captain](#). After the Ceremony, he approached [Major St. Ardentia](#) with a drink, introduced himself, and asked why she appeared so expectant of danger. [The Ambassador](#) and [Specialist Quint](#) entered the conversation to assist the Major and prevent the incident disclosure of confidential information.

-Specialist Quint has confirmed that Saends is a psyker, and is very skilled at hiding his presence and abilities.

-Saends regards [Pax Velanus](#) as "canny," and someone to be wary of.

[Heavy Encryption]

-[Ford](#) is passing some information to Saends that we deem valuable to his continued inaction toward the company; however, he also revealed that he'd been outfitted with a Vigil Device, such that he could avoid questions that might lead to more dangerous revelations. Controlling what Saends knows has been made both easier and more difficult.


Asclepius 32-B



-First encountered in the [Purge](#) of [Bluehull-92](#), where he was rescued from [holding](#) and assisted the team in purging the habblock.

-Suspected clone.

Interrogator Gideon



-Interrogator previously in charge of [Norimar Investigation](#); current mission and whereabouts technically unknown, but I have suspicions that Gideon may be another identity of [Arcelius Montalban](#).

-Confirmed association with [Solomon](#), under alias "Brother Gideon." The psykers considers his Interrogator to be a traitor, though the precise regard and veracity of this claim has yet to be established.

The Inquisition

Interrogator Arcelius Montalban



-Interrogator Montalban is not part of the Ordo Hereticus, and therefore not a member of Lord Inquisitor Kabella Vyne's Retinue; rather, he represents the [Ordo Historica Veritas](#), and seeks to uncover the [secret histories](#) of Asterion. We have since opened negotiations for cooperation with the Interrogator, as elements of our aspirations currently align; though generally any interaction with the Inquisition is prudent to avoid, our position within the complexities of Asterion's politics has made this impossible, and thus controlling the nature of all interactions is the best outcome we

can strive for moving forward.

-To this purpose, Montalban has provided us with a means of communication using dead drops to be delivered by his acolytes.

-Montalban was first brought to our attention when [Commissioner Comata](#) reported alleged [acolytes caught stealing the cypher ident of a navy official](#). Two more of Montalban's acolytes—Tongs and Thunder (given name Remus, thus all other names given can be assumed to be codenames)—were later encountered during an operation to locate [Archivist Denn](#) and the documents he'd uncovered in Level 442 of the Administratum Archive. Circumstances aligned such that we were able to join forces with the acolytes.

-Our first direct meeting with Interrogator Montalban occurred in the mid hive, at [the Chapel of St. D'Chessia on Level 77-K](#). He is adept at subtly controlling conversations by inviting people to talk more about themselves, while deflecting questions about himself. His amiable behavior likely is a method to cause others to underestimate him.

-[The Quarantine Event of Level 77-K](#) occurred during this meeting; we suspect that Montalban was the intended target of assassination, and as such, we have advised him to look for moles in his organization.

-Agrees that House Fontarii is likely the 3rd, missing noble house of Asterion. However, he has some additional theories that may prove problematic for us if revealed, specifically that [Melichdoche Traquiel](#) framed House Fontarii, and betrayed [Captain Orpheon](#).

-I suspect that Interrogator Montalban and [Interrogator Gideon](#)/Brother Gideon are one in the same, based on his explanation of a sending an acolyte into [Halcyon](#) who's story matches that of [Solomon](#). Though he was not able to gain a large amount of intelligence from his spy, he was able to confirm that the Order uses Asterii Devices; his condemnation of this behavior leads me to conclude that we should under no circumstances disclose our own utilization of such technology.

-A newer "upstart" faction of the Imperial Cult; populist and largely supported by the lower class.

-Have been given use of the [Chapel](#) and [former Hydroponics Facilities](#) in [Bluehull-92](#)

-Recent reports indicate that the Regulars are becoming divided into two camps of thought, one that seeks more aggressive action the [Eternalites](#), and one that wants to focus on defensive measures and maintaining their current position.

-Heavy Encryption-

-The devotion of followers has led to some questionable actions, including an attempt to fake a miracle by using heretical device. (Xenotechnology can now be added to this list, following the [Investigation of Spire Thor](#))

-Incarcerated Individuals associated with the Regulars have been assigned longer terms by the [Penance Guild](#), as proven by acquired data.

The Clerics Regular of His Holy Canon

Preacher Doran Smythe



[Major Recent Events]

-Doran has bonded with a Redressor Device; curiously, his use of its power manifests as an aura that targets all nearby entities.

-Leader of the Clerics Regular, persistent humility in the face of near worship from his followers.

-Rumored to be a living Saint; now referred to by many as "St. Doran the Kind." However, his recent loss of confidence and lack of miracles has caused him to lose some traction. This indecisiveness has created tension within the Regulars that is moving toward a schism, led in part by [Preacher Jharn](#).

-Believes that the [Eternalites](#) have chosen wealth over faith.

-Has survived numerous assassination attempts, and is in incredible health, and has a remarkable healing factor.

-Very humble, and tries to ignore assertions of his Sainthood to maintain his grounded perspective.

-Disliked by [Witch-Breaker](#)

-Officiated the Gubernatorial Wedding, though required the encouragement and wisdom of [Preacher Enoch](#), who he seemed to look up to, in order to do so.

[Heavy Encryption]

-Doran's miracles have been confirmed to be caused by intervention of the [Philotes Device](#), prior to the capture of Solomon. Future miracles are intended to be facilitated by use of the [Nemesis Device](#). Doran was unaware of these circumstances.

[Additional Encryption]

I have chosen to tell Doran the truth about his miracles having been the result of a psyker's intervention. My decision was predicated on the reports of his loss of confidence in himself as a servant of the Emperor, and a belief that while the revelation would be initially painful, it would allow him to move past a perceived loss of ability.

Reports from Yvestina do indicate that he is improving, though the loss of Preacher Enoch dealt another significant blow to his spirit.

Following the congregation publicly showing Harkan Jharn to have healing abilities (if secretly by means of an overseeing member of Halcyon), Smythe asked me if this was the same power I had revealed to be behind his miracles; I was careful not to reveal too much of the nature of Devices, but did put forth the truth that Jharn had the aid of a holy artifact, anathema to the archenemy. Smythe wondered if he had found this relic on a pilgrimage to [Vallis Decimae](#).

Given that Doran remains unconvinced by the push towards aggression, and desires to lead the Regulars on the path he sees as true, I have suggested a pilgrimage to gain a holy artifact might be possible. I have suggested that such relics can only be wielded while the convictions of the user remain true; this should allow us to remove Jharn or his abilities without contradiction—I have suggested that his zeal may lead him to burnout—though killing him may still be a simpler means of handling the situation.

This pilgrimage could very easily involve traversing the challenges of [Fort Orpheon](#), as the Devices are already present in the [Null Singularity](#) Chamber.

Solomon (Deceased)



[Heavy Encryption]

-The semi-deceased psyker currently in possession of the [Philotes Device](#); see [Spire Thor Investigation Report](#)

-Zealously loyal to and obsessed with [Preacher Doran Smythe](#)

-Confirmed association with [Interrogator Gideon](#); psychic interrogation has revealed that Solomon was previously a member of the Inquisition. Based on discussions with [Interrogator Montalban](#), I suspect that Solomon was sent to infiltrate [Halcyon](#), which is a plausible theory as to how he gained a Device.

-Though much of his higher mental function was impaired from his physical condition, preventing more than basic and somewhat distorted accounts of information being conveyed, his responses to questions indicated that he was indeed a sanctioned psyker, (in his words, "born to darkness and granted the Emperor's light) and used his power in the defense of the Imperium. Additionally, he appears to have gained the Philotes Device (referred to as a tool of the Enemy) during a "great betrayal" at the hands of Gideon.

-The origin of his fixation on Doran could not be determined; however, he views the Preacher as a true servant of the Emperor, and his inspiration to free himself from the Enemy. He views himself as Doran's most devoted servant, and believes his purpose is to serve the "grandeur of the Living Saint."

-Unlike [Lazarus](#), Solomon's body showed no sign regenerating from lethal injury; however, his soul remained in the Philotes Device, apparently preventing another being from fusing with the relic. We were eventually able to purge his soul using the [Null Singularity](#), after which Ambassador Lethe bonded with the Device.

-Following the launch of the incursion, Jharn took his followers on a crusade through the lower hives, hunting down mutants and looting armaments. Whether Halcyon continues to aid him, and whether this crusade will ultimately help or hinder mankind, is unclear at this time.

[Previous Reports]

-Proponent of aggressive policies against the [Eternalites](#); currently proposing a schism to create the Clerics Bellatori

-Possesses the confidence that [Doran](#) currently lacks, and has gained a massive increase in popularity following the revelation of healing powers during a major congregation.

-[Pax Velanus](#) has instructed [Sister Yvestina](#) not to interfere, but Avarast feels that something should be done to prevent Jharn from splitting the Regulars.

-Jharn has formally called for war against the Eternalites; [Major Verity](#) has situated herself as an ally in planning the offensive, giving us a means to track the progress of their plans.

[Heavy Encryption]

-Yvestina also reported that Jharn's closer retinue is largely comprised of newcomers to the Regulars that she is less familiar with. [Major Verity's](#) investigation revealed that one of these individuals is a sanctioned psyker, indicating the rest also merited further examination. [Ford](#) used his Inquisitorial contacts to confirm that the IDs of individuals are high quality forgeries, perhaps indicated that Jharn and his team are Inquisition or have Inquisition contacts.

-Recent evidence indicates that these highly connected individuals are not Inquisition, but [Halcyon](#) affiliated; one is clearly outfitted with a [Redressor](#).

-Undertook a pilgrimage to Vallis Decimae recently; given the connections gained to Halcyon, I am led to wonder if the Order may have a presence in this region.

Brother Tyrantus Ames

-A member of [Harkan Jharn's](#) Retinue; possesses high quality false identification documents; likely connection to [Halcyon](#).

-Was "miraculously healed" by Jharn (or rather, a Redressor device used by another of the Retinue) during a major public congregation.

Deacon Pollux

-A member of [Harkan Jharn's](#) retinue; possesses high quality identification forgeries; likely connection to [Halcyon](#)

The Eternal Order of Saint Yontericus the Twice Martyred (Eternalites)

(-3 Influence)

-Dominant sect of the Imperial Cult in Asterion, though their position has been challenged in recent years by the growing popularity of the [Clerics Regular](#).

-Rich, well connected; regularly hosts and presides over major religious events.

-Has strong ties to the [Penance Guild](#).

The Eternal Order of Saint Yontericus the Twice Martyred (Eternalites)

Abbess Frontilia Disteldort



-Elderly woman

-Has strong opinions on the spiritual value of poverty.

-Attended the Gubernatorial Wedding (though left immediately after the ceremony); gifted the couple with a Reliquary Blade of extensive history (for Dehvon) and a "Relic" necklace with no known story in Keojrah-Glynt colors (for Ambassador Lethe); though this may have merely been a studied insult, the necklace is being examined for threats.

-Called "Yvvie" by [Sister Reverenita](#)

[Heavy Encryption]

-Has since revealed to [Major Verity](#), with whom she has established some rapport, that part of her mission involves determining whether Smythe is indeed a Saint, or something darker; wants to believe in him, because he does good things, but she cannot take this on faith. She since has become convinced of his goodness, but perceives that he has lost faith in himself, following his inability to perform miracles. This report has also disappointed [Sister Velanus](#).

-Rumors were spread claiming the Sister to be an apostate, no longer associates with the Sororitas. These claims were investigated with the aid of [Sister Laria Majas](#), and proved false by the response of [Canoness Preceptor Hope Amolaia](#).

-Sororitas dispatched to aid in defending the spiritual health of Asterion; in this regard, has expressed that [Abbess Distledort](#) shall soon be abdicating her position as head of the [Eternalites](#), due to her cavalier accusations of Apostasy of a [Sister](#) in good standing.

-In joint command of a detachment of sisters put to the same cause with [Sister Laria](#); they are part of the same house, the Order of Hallowed Glass. Laria was somewhat concerned about the arrival of Velanus, having stated that she tends to be somewhat unyielding, and may not approve of [Kelle's](#) marriage to [Dehvon](#). It is as of yet unclear whether these concerns are grounded in reality.

-With Sister Laria returning to Isadore's Rest for an indeterminate amount of time, likely due to reported suspicions from Pax herself, Velanus will be our primary point of contact with the Sororitas for the foreseeable future. Additional research into her history shall be conducted, to prepare for possible hostility.

-[Yvestina](#) has reported a notable difference in Velanus's approach to running Sororitas Operations on Asterion; specifically, between more tactical moves and consolidation of power through exacting tithes, she believes the Famula Advance intends for the faction to become a more major political force. She is not confiding her exact intentions to anyone.

-[Ford](#) reported that [Interrogator Saends](#) warned him to be wary of Velanus and her intelligence; that the Interrogator is cautious about the Famula Advance is cause for no small amount of concern.

-Velanus met with [the Major](#) prior to meeting with the rest of the company, and asked several questions about our operations, specifically concerning:

--Dehvon's relationship with Kelle

--Xenotechnology on Asterion (she was surprised to learn of [Sojourner Wakes's](#) death).

--[The Prophecy of the Golden Gaze](#)

--Enemies of the KG-Co and House Traquiel on Asterion

--Experiences with and assessment of Laria Majas.

-During this discussion, the Major revealed nothing of a confidential nature.

-Later, during a meeting with Ambassador Lethe, inquired as to progress of producing an heir to the Traquiel lineage.

-[Father Lightfall](#) sent an agent to keep watch over Sister Laria while she is off world. This agent has since reported that she has been reassigned, and will not be returning to the planet, making Velanus the sole raking Famula on Asterion.

The aid of KG-Co in recovering the [Abducted Arbitrators](#) makes it all the more likely that she will side with us and the Regulars when the time comes.

-Attended the Gubernatorial Wedding; gifted the couple a set of master crafted tomes of the Lex Imperialis.



-Pleased with the resolution of mechanical difficulties aboard [Port Lysander](#).

-Attended the Gubernatorial Wedding alongside several Navy Ship Captains; gifted the couple a Navis Grata Dignitatum token of transit, and an evening demonstration of Naval ships and artillery, for entertainment.

-Interestingly, von Trakkyr expressed gratitude in our siding with the [Clerics Regular](#) over the [Eternalites](#) (though this may simply be due to the fact that our support indicates a speedier conclusion of the conflict in general). In a recent conversation, she extended an offer to Preacher Doran (to be conveyed by us) that if the hostilities should increase to unmanageable levels, the Navy would take in the Regulars under threat. This seems like an attempt at conscription.

-At the wedding, she took care to remind Kelle of Asterion and Port Lysander's importance in the Logistical Networks of the Cytheris Subsector, likely to determine whether we take such matters seriously.

-Von Trakkyr supports [Magos Dominus Voltaire's](#) bid to succeed [Wakes](#) as the Archmagos, believing that his promotion would aid the war effort.

-The Rear Admiral has contracted the work of [Magos Techsorcist Voss Alpha-1](#) to purge a scrap code infection from a navy warship, *the Judgment of Eminence*. She requested that we determine whether he was making progress, and/or capable of completing the task; we have assessed both to be true.

-In the wake of the events in [Void Dock 102](#), the Rear Admiral has become concerned about the presence of [stealth technology](#) used on the small craft vessel that collided with Port Lysander. She is actively seeking additional information on this technology, and I have been assisting in the analysis. She has also informed us that, given the typical use of such technology involving the Aeldari, [the Inquisition](#) is likewise investigating.

-Seems to have a positive view of our agents and relationship, particularly following our arbitration on a manslaughter case at [the Dock](#), in which we decided to invest reparations paid by the noble perpetrator to the family of the victim and the Hourglass Gang for their ongoing service.

-Has demonstrated an understanding of the gang's role as both the enforcers of the Dock and part of the experience being offered; has altered the appearance of her operatives to match the more theatrical expectations of the nobles that attend.

-Has demonstrated a readiness to execute heretics.

-King Quinque returned from his pilgrimage, presumably as a fully fledged fivefold champion, as Lady von Tarquinius was launching her incursion on Asterion; he was thus able to rescue Ambassador Lethe from certain death.

-He has stated that the attack on Asterion is an opportunity to launch a fatal attack against Nurgle; the details of this plan can be found [here](#).

[Prior Reports]

-Harlequin Solitaire—soul gambled between the Laughing God and Sai'lanthresh/Slaanesh, acts the role of the latter in Harlequin plays. It is for this reason that he has bonded with a [Condemnor](#), intending for his soul to be destroyed/consumed, rather than letting it potentially fall into the hands of a chaos god after his death.

-[Anvephone Traquiel's](#) mysterious mentor; I strongly suspect that he has also given guidance to the Wakes Cognomen line, and perhaps instilled the notion of "crusade" as mentioned by [Sojourner Wakes](#).

-Contacted [Ambassador Lethe](#) in a dream, then via an aeldari hard-light hologram. A more permanent connection point has been made via Kelle's [Communion](#).

-Following the trail and philosophy of the [Asterii](#); is a Third Order Champion, bonded with an [Augmentor](#), [Redressor](#), and Condemnor. Seeks to kill a chaos god (Nurgle, Captor of Isha), and wishes us to be allies in this endeavor.

-Wishes to know what is inside, but cannot enter, the [Asterii Cathedral](#); explained that this limitation was due to his own choices, though not what those choices were. Additionally mentioned that there are four Wards in the Cathedral, instead of the expected five. Upon exploration of the Cathedral, a conclusion can be drawn that individuals bearing a Condemnor are held in low esteem by Asterii culture, and not allowed to enter such locations as the Cathedral.

-Gifted us an Augmentor, as proof of goodwill, which has been bonded to [Verity](#) (note: [Lazarus](#) was incapable of bonding with the device, indicating that specific protocols must be followed to equip more than one).

-After the exploration of the Asterii Cathedral, we provided King Quinque with a [Voiddelver](#) and a [Communior](#). He has promised to teach us the initiation rights to become higher order champions ourselves, after he has become a Fifth Order Champion under the supervision of whatever council of entities is currently guiding him along the same path; this is apparently the proper way of doing things.

Unaligned/Unknown Affiliation

Palinea Traquiel/The Golden



[Heavy Encryption]

-Daughter of [Anvephone Traquiel](#) and another woman who provided the paternal component of genetic material.

-Mutated spontaneously at two weeks of age to have golden eyes, two rows of needle teeth, and some form of Immaterium related abilities. Could only consume raw meat. At some point developed a third eye on her forehead, similar in some regard to a navigator eye.

-Anvephone's [personal logs](#) indicate that Palinea may have been born a Blank, before her changes manifested.

-Remarkable semblance of mutation to an [ancient prophecy](#) regarding a fang toothed child who would bring salvation from the forces of chaos to Asterion.

-Was eleven years old at time of initial death, but due to accelerated aging resembled an adult woman very similar in appearance to her mother.

-Kept contact with her mother after vanishing from the palace five years ago; raided meat vats for sustenance; seemingly developed a cult of followers in the lower hive who believed in her divinity.

-Palinea claimed to be a servant of the Emperor, not the forces of the archenemy.

-[Sister Majas](#) sought to kill the mutant scion; KG Co operatives assisted in this assassination to secure an alliance with [House Traquiel](#). However, some time after her death, [Specialist Quint](#) recovered her perfectly preserved soul from the Immaterium, describing it as having been held by an entity that willingly relinquished it to him. Her soul became housed in a pair of [Servitors](#) altered with psychic circuitry by [Nepheli Havelock](#). Per instructions of [Ambassador Lethe](#), these servitors have been dismantled and incinerated; the state of Palinea's soul is unknown, but has possibly returned to its preserved state in the Immaterium.

-Lazarus's affinity for Palinea and the lack of hostile reaction from the [Nemesis Artifact](#) serves as possible evidence that she is not a chaos entity, as the device has previously demonstrated a tendency to violently purge any taint of the archenemy. There is precedent for mutants existing within Imperial Sanction, such as Navigators.

-When prompted with the command "Truth," by Quint via the Nemesis Device, projected a vivid and highly detailed [vision](#) of the imminent destruction of Asterion.

- Captain of the private/pirate vessel Absence of Decorum; provided transport to our company to the [Asterii Cathedral](#). Following the [success of this mission](#), was provided a bonus for having withstood unforeseen threats (ie, the Chaos Ship), and sent contracts for further cooperation.
- Contracted by KG-Co for transportation and trade in the Macharian Sector.
- Thus far, has shown satisfactory understanding of the need for secrecy regarding KG-Co activities.



-De Facto leader of the 508; the title of Ssar derives from Commissar, which exists in the form of the character Comi Ssar in their lore (the original leader who brought the 508 to their position, and set their course of action).

-Believes strongly in their mission, and Comi Ssar's belief that cut off from the surface, the Guard would achieve a utopia of sorts, able to fully perform their purpose in peak condition. Views any circumstance that could break their line as a threat to the 508's existence; will not allow any of the Guard to leave, and views outsiders with skepticism. (Explained that while some have joined, some have attempted to steal from them; presumably others have threatened their way of life philosophically.)

-Forwards the belief in a Final Conflict with the Enemies of Mankind, which they must remain prepared for; as such, attempted to restore the Reserve that had apparently perished within its stasis pod (before she had been born) by replacing it with [Magos Vector van Flange](#). The original Reserve's nature has been lost to time, but it has been described as a hero, and "anathema to the Archenemy." Might have been a man or a beast; some records indicate it was a "soulless creature," perhaps indicating a robotic entity or a Blank. Use of the stasis pod is more indicative of a biological entity.

-[Ambassador Lethe](#) negotiated a deal with Wolstina; KG-co will supply the 508 with supplies, munitions, armaments, and so forth in exchange for their surplus Cutters, and the nutrient rich goo they provide.

Clan Enge Seers



-Current "Seers" (seemingly derived from Engineers) are Mab and Mas of Enge, trained by the recently deceased Mag of Enge.

-Possess some knowledge and skill regarding the maintenance of the Reactor, though they lack proper training in standard protocol and care of machine spirits. However, they are willing to receive instruction from credible sources.

Sarge-Captain Graem of 2nd



-One of the officers running the defense of the front line.

-Wants to use ordinance to collapse the tunnel of Westgate, putting him at odds with [Omera Rutel](#) (who seeks to save their limited explosives) and the [Ssar](#) (who is concerned with the possible risk to the Fungal Farm).

-Doesn't believe in "the Big One," and is more concerned with the ongoing survival and welfare of the 508 in the immediate future.

-A former archivist of the [DeWonti Trade Consortium](#); initial appraisal of his abilities shows promise for recruitment, however his his strong self-preservation instinct may indicate against entrusting

him with sensitive material of any kind.

-After locating the dead body of an acquaintance who had apparently been killed by the Consortium, he himself was targeted for execution, but managed to flee; he sought the aid of Keojrah-Glynt Company due to our existing rivalry/hostilities with DeWonti, in hopes that he could trade information for protection.

-Chemical interrogation and follow-up on his leads have corroborated his claims; though it is hypothetically possible that resisted these methods, and that our successful mission on the abandoned [Fungal Farm](#) was a ploy to gain our trust, I believe the existence of the [Procuratia](#) to stand in contradiction to this possibility, as I do not believe [Lady von Tarquinius](#) would have risked (or chosen to use) discovery of such valuable and heretical tools in such a scheme. Indeed, I believe it was the discovery of the Procuratia's existence that led Vek's acquaintance to be terminated, as he had apparently been investigating the disappearances of the women that I believe were to undergo the proxy procedure.

-Vek's information has further provided us with the ability to decrypt DeWonti transmissions, and possible access to the Starlight's Boon. Both assets must be used carefully, to avoid detection. The Cryptographic Cyphers have proven useful via the aid of [Kelvin 111](#) and the [Comutotitron Chapel](#).

-Vek has dispatched to the 508 as a defensive measure to the interests of the DeWonti Trade Consortium; he has been instructed to assist them with logistical administration, and to pass information back to KG-co when relevant.

-Interrogation of interlopers/infiltrators into [Bluehull-92](#) indicate her ongoing interest in [Wynnyf von Bjekt](#); the behaviors of these agents further indicate possible heretical sympathies. This further lends to a conclusion that the voidborn agents seeking Wynnyf in tandem to our operation; given that the [Astra Telepathica](#) was similarly interested in the latent psyker's whereabouts, it is unknown whether they were at odds with Lady Tarquinius, in league with her, or unaware of her.

-Part of the attack on [Headquarters](#) that occurred during the [Night of Revenge](#) was likely orchestrated by Lady von Tarquinius, based on the behaviors of the psyker infiltrator that killed one of the guards and planted a thermite charge in the power station. These hypotheses cannot be confirmed through investigation of the subject, due to the circumstances of their defeat.

-Since experiencing the [Vision of Truth](#), assessing the [intentions of Lady von Tarquinius](#) has become a high priority. These concerns have been verified in the [Fungal Farm Raid](#) and the [Arbitrator Kidnapping Investigation](#).

-Seemingly capable of projecting her will and abilities through proxy creatures called "[Procuratia](#)," including assumption of direct and complete control. She can also inflict a form of demonic possession upon these subjects, which seems to end if the psychic link is severed.

-In a proxy conversation, the Lady Navigator claimed that her actions were elements of a "forward thinking" plan, and showed interest in purchasing psykers. She appears to have a particular interest in [Lazarus](#), whom she recognizes from the [Traquiel Palace Party](#), though she was not in obvious attendance of that event, and despite our attempts to hide his identity. Little else could be established about her intents and motivations at this time, though it is clear that she has been observing the Keojrah-Glynt Company for some time.

-Lady von Tarquinius also attended the Gubernatorial Wedding via possession of a Procuratia.

-Requests have been sent off planet for additional reinforcements of Clan Pelnikt agents; we should expect their numbers to increase.

-The report located by Denn was sought not only by our team and agents of the Order (allied with or synonymous with the Ordo Historica Veritas), but Inquisitorial Acolytes of [Interrogator Montalban](#), and [Ordinate Iulianus Tacitus](#), an agent of the Logos Historica Verita.

-Was killed prior to our team's arrival, likely by [Ordinate Kef Moevell](#).

-Former office-mate of "Skench," who—despite proving useful in our attempts to locate Denn (doubly so for having hindered the investigation of Kef)—I cannot classify as a full asset, given that his work is already filling his mental capacity to the point of requiring additional stimulants.

-Survivors of the Mityellan 3rd Armored Division, honorably discharged after a long, harrowing campaign on the moon Eventide. Now a company Mercenary Company of some 60 highly skilled troops, who we might be able to recruit, should we earn their trust and goodwill.

-Have a score to settle with Inquisitor Roke; their final conflict on Eventide involved large casualties when facing the forces of Roke, who they believe was trying to hide something on the moon. Specifically, they suspect that he was trying to claim and hide Xenotechnology. It was after this conflict that they were discharged, apparently due to the politics and secrecy behind the encounter.
